We believe it's because every child benefits when they succeed. So we provide opportunities that transform the lives of our Kinetic Kids.

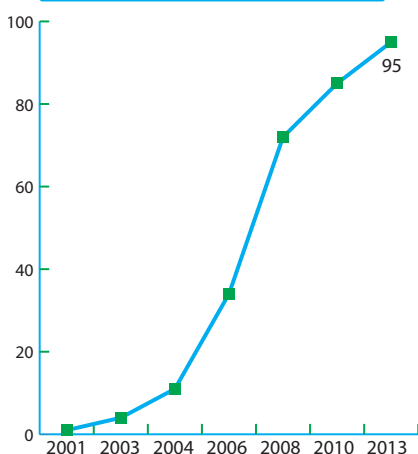


A wonderful opportunity for my child! He learned lifelong skills and his confidence was boosted while giving him a sense of belonging.

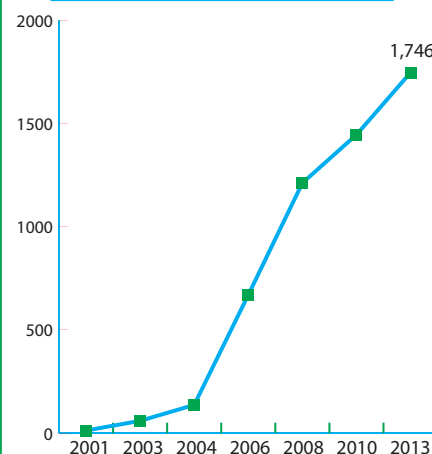
What Makes Us UNIQUE

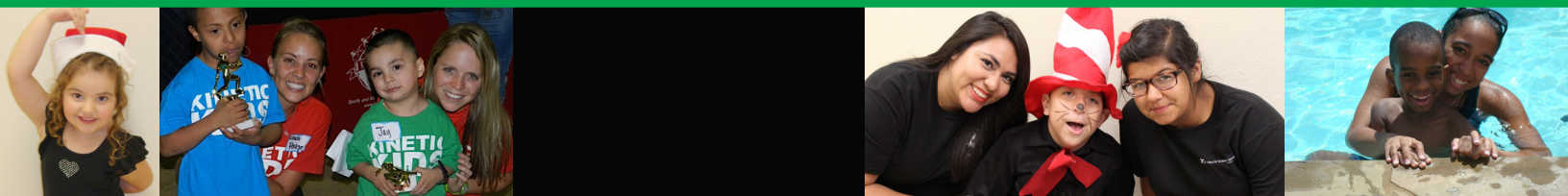

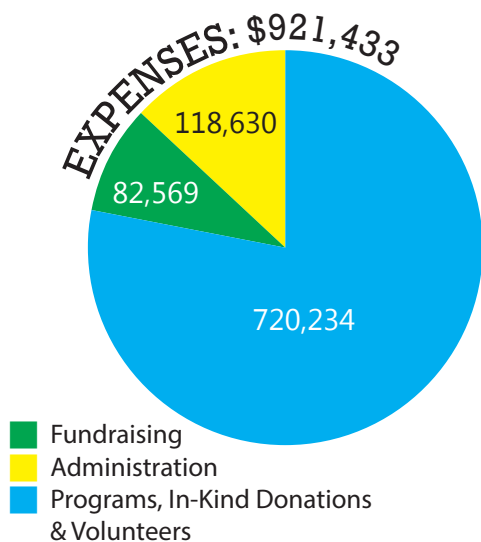

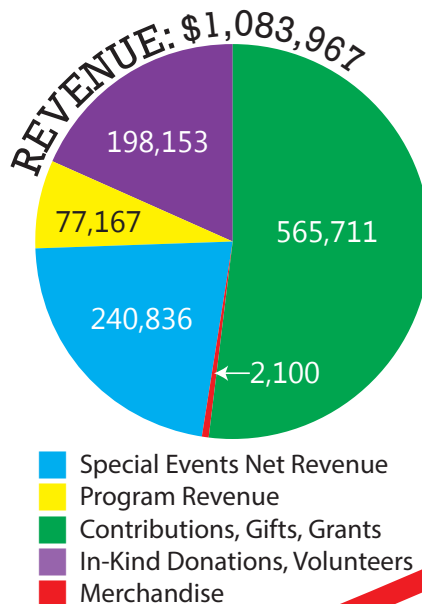
